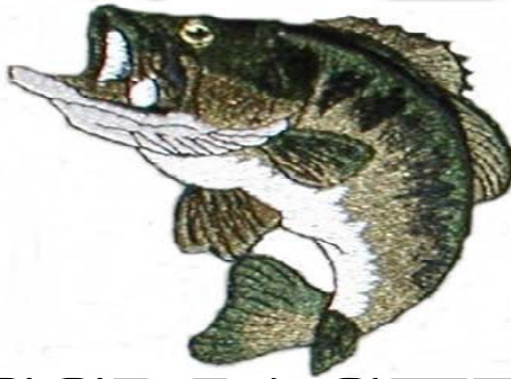

TOURNAMENT RULES

1. TOURNAMENT HOURS ARE 6:30PM UNTIL 6:30AM
2. ALL BOATS MUST BE IN BUOY AREA BEFORE THEIR DESIGNATED TIME OR BE DISQUALIFIED.
3. ALL FISH BROUGHT TO THE WEIGH-IN (EXCEPT TROPHY BASS WILL BE RETURNED TO THE WATER.
4. ONLY LARGEMOUTH, SPOTTED AND RED EYE BASS WILL BE WEIGHED.
5. MINIMUM LENGTH TO BE WEIGHED SHALL BE (12) TWELVE INCHES ON THE GOLDEN RULE. ANYONE WEIGHING IN A FISH SMALLER THAN TWELVE (12) INCHES WILL BE PENALIZED BY CULLING HIS OR HER LARGEST FISH.
6. THERE IS A 5 FISH LIMIT PER BOAT. BRINGING MORE THAN 5 FISH TO THE SCALES WILL RESULT IN DISQUALIFICATION.
7. NO TROLLING, JIGGEERRPLOING, LIVE BAIT, WADING, ARTIFICAL LURES ONLY.
8. CONTESTANTS WILL ABIDE BY ALABAMA WATER SAFETY STANDARDS.
9. ONE CONTESTANT'S BOAT CANNOT FISH OR ANCHOR WITHIN 150 FEET OF ANOTHER CONTESTANT'S BOAT.
10. CONTESTANTS WILL WEAR A LIFT JACKET AND HAVE A KILL SWITCH ATTACHED TO THEIR PERSON WHEN THE MAIN MOTOR IS RUNNING.
11. NO ALCOHOLIC BEVERAGES WILL BE ALLOWED ON THE LAKE.
12. A MAXIMUM OF **ONLY 2** DEAD FISH WILL BE ALLOWED. BRINGING MORE THAN 2 DEAD FISH TO THE SCALES WILL RESULT IN AUTOMATIC DISQUALIFICATION.
13. WINNERS MAY BE REQUIRED TO PASS A POLYGRAPH TEST TO QUALIFY FOR PRIZE MONEY.
14. **ALL FISH MUST BE WEIGHED BEFORE TRAILERING YOUR BOAT. FISH BROUGHT FROM THE PARKING LOT WILL NOT BE WEIGHED.**
15. **ENTRY FEES CASH OR CHECK THE DAY OF THE TOURNAMENT.**
16. ANY TIES WILL BE DECIDED BY THE TOURNAMENT COMMITTEE.
17. ANY CONDITIONS ARISING WHICH ARE NOT COVERED BY THE ABOVE RULES WILL BE RESOLVED BY THE TOURNAMENT COMMITTEE AND ARE FINAL.
